#### **EXPLANATION**

This authority issued Permit no. After reviewing the submitted documentation, in accordance with the expert opinion of the Waste Management Department, the Environmental Office with athibio no. Up1-31-1419/2020 from 19.11.2020 in accordance with the Article 66 from the Waste Management Law ("Official Gazette of the Republic of North Macedonia" no. 68/04, 07/07, 102/08, 143/08, 171/08, 124/10, 9/11, 51/11, 132/12, 147/13, 163/13, 51/15, 146/15, 156/15, 39/16 and 63/16), it was assessed that the existing Permit for collection and transport of hazardous waste with no. Up1-31-629/2020 issued on day 29.06.2020 and in accordance with the above, this Decision is issued for the needs of the legal entity for performing the business activities related to the above mentioned permit.

Instructions for legal remedy: An appeal can be filed against this decision to the State Commission for deciding in an administrative procedure for employment in the second degree, within 15 days, taxed with 250.00 denars and administrative fees in cash on a payment account 840 xxx 031 16 within the treasury account.
