Based on Article 87 paragraph 1 of the Law on General Administrative Procedure ("Official Gazette of the Republic of Macedonia" No. 124/15), article 64, paragraph 1, item 2 of the Law on Waste Management ("Official Gazette of the Republic of Macedonia" No. 216/2021), the Department of Environment/Waste Management Sector, acting on the request of the legal entity DSPPO export-import Ekocentar 97 DOOEL Skopje, brought the following:

Argumentation

The applicant DSPPO export-import Ekocentar 97 DOOEL Skopje, with headquarters at ul. Gjorgi Kolozov, no. 10, Gazi Baba municipality, Skopje, on 07.09.2023, submitted a request with arch. no. UP1-11/2-1955/2023 to the Ministry of Environment and Physical Planning, the Department of Environment/Waste Management Sector, for expanding their activity with the following codes from the list with types of waste, namely: **01 05 05*, 01 05 06*, 02 01 08*, 03 01 04*, 03 02 01*, 03 02 02*, 03 02 03*, 03 02 04*, 03 02 05*, 04 01 03*, 04 02 14*, 04 02 16*, 04 02 19*, 08 03 07, 08 03 08, 08 03 13, 08 03 15, 08 03 18, 08 03 19*, 17 01 07, 17 02 01, 17 02 02, 17 02 03, 17 03 02, 17 09 01*, 17 09 02*, 17 09 03*, 18 01 06*, 18 01 07, 18 01 08*, 18 01 09, 18 02 05*, 19 07 02*, 10 07 03, 19 10 02, 19 12 06*, 19 12 11*, 19 12 04, 19 12 05, 19 12 07, 19 12 08**, for the purpose of storage and treatment of the same within the scope of the existing permit for storage, treatment and/or processing of waste with Arch. No. UP1-11/2-2483/2022, issued on 17.03.2023, valid until 16.03.2023.

After reviewing the submitted documentation and the decision to approve the elaboration on environmental protection, and the performed inspection of the installation on 28.09.2023, the Department of Environment/Waste Management Sector, on 29.09.2023, issued a positive opinion on the request and issued a Decision to expand the activity with the abovementioned codes from the list of types of waste, with the purpose of storing and
