REASONING

The applicant DSPOO izvoz-uvoz Ekocentar 97 DOOEL Skopje Podruznica Eko Neopasen Otpad 3 Sveti Nikole, with headquarters at ul. Marshal Tito br. 75, Sveti Nikole, on 03.07.2025, submitted a request with arch. no. 11-2992/5 to the Ministry of Environment and Physical Planning, the Environmental Administration/Waste Management Department, for the extension of the existing permit for collection and transportation of hazardous waste with no. Reference 11-2992, issued on 20.06.2025, valid until 20.06.2035, and within the scope of the existing Permit, the above codes from the list of types of waste will be added.

After reviewing the submitted documentation, and the Decision on approval of the report with nr. 11-340/2, the Environmental Administration/Department for Waste Management, on 11.07.2025, gave a positive opinion on the request and issued a Decision to extend the Permit with the following codes from the list of types of waste: 07 02 13, 15 01 01, 15 01 02, 15 01 03, 15 01 04, 15 01 05, 15 01 06, 15 01 07, 15 01 09, 15 01 10*, 15 02 02*, 15 02 03, 16 01 03, 17 02 01, 17 02 02, 17 02 03, 17 02 04*, all 17 04(except 17 04 09*, and 17 04 10*), 19 12 01, 19 12 02, 19 12 03, 19 12 04, 19 12 05, 19 12 06*, 19 12 07, 19 12 08, 19 12 09, 19 12 12, 20 01 10, 20 01 11, with the purpose of collection and transportation thereof, in accordance with article 64, paragraph 1 point 2 of the Law on Waste Management ("Official Gazette of the Republic of North Macedonia" No. 216/2021).

Pursuant to the aforementioned and the Rulebook on the requirements to be met by the entities for obtaining a waste management permit, the form and content of the application form for obtaining a waste management permit and the method of submission of the request, as well as the form and content of the template of the permit for performing waste management activity ("Official
